

## **CERTIFICATION**

I, JESSIE R. REOTUTAR, Corporate Board Secretary of Small Business Corporation, hereby certify that the performance of the Board and the five (5) Board-level Committees for CY 2019 were assessed using the following:

- (a) Performance Scorecard for the Governing Board as approved by the Board per Board Resolution No. 2018-12-2681. The assessment covered the following key areas: Meeting and Participation (25%), Transparency (25%) and Quality of Governance (50%);
- (b) Performance Scorecard for the five Board-level Committees; namely, Corporate Governance Committee, Board Audit and Compliance Committee, Finance and Risk Oversight Committee, IT and Platformification Committee (formerly Board Oversight Committee on Technology and Information Management), and Board Committee on Venture Capital Review as approved by the Board per Board Resolution No. 2019-05-2751. The assessment covered the following key areas: Meeting and Participation (20%), Transparency (10%) and Performance of Mandate (70%).

For the Governing Board, 8 out of 9 incumbent members participated in the assessment. Based on the assessment, the Governing Board was assessed with an average numerical rating of 93.38% or a weighted rating of 4.67, indicating a Very Satisfactory performance as more than majority of members consider the Board to have performed its functions under the 3 key areas.

## For the four Board-level Committees:

- (a) Corporate Governance Committee 4 out of 5 members participated in the assessment. The CGC was assessed with an average numerical rating of 91.25% or a weighted rating of 4.56, indicating a Very Satisfactory performance as more than majority of members consider the CGC to have performed its functions under the 3 key areas;
- (b) Board Audit and Compliance Committee all the 3 members participated in the assessment. The BACC was assessed with an average numerical rating of 93.00% or a weighted rating of 4.65, indicating a Very Satisfactory performance as more than majority of members consider the BACC to have performed its functions under the 3 key areas;
- (c) Finance and Risk Oversight Committee all the 3 members participated in the assessment. The FROC was assessed with an average numerical rating of 85% or a weighted rating of 4.25, indicating a Very Satisfactory performance as a simple majority of members consider the ROC to have performed its functions under the 3 key areas;
- (d) IT and Platformification Committee all the 3 members participated in the assessment. The ITPC was assessed with an average numerical rating of 96.33% or a weighted rating of 4.82, indicating a Very Satisfactory performance as more than majority of members consider the ITPC to have performed its functions under the 3 key areas;

(e) Board Committee on Venture Capital Review - all the 5 members participated in the assessment. The BCVCR was assessed with an average numerical rating of 92.00% or a weighted rating of 4.62, indicating a Very Satisfactory performance as more than majority of members consider the BOCTIM to have performed its functions under the 3 key areas.
