1. Section X – Terms of Reference:

a. Item VIII - Must have service centers in the following areas:

b. Item IV – Technical specifications/features indicated below are amended as follows:

c. Item V – Delivery and Inspection, paragraph 1:

Vehicle must be delivered by the winning bidder within TWO (2) WEEKS upon receipt of Notice to Proceed (NTP) or by 27 December 2024	The same with the original schedule (no revision).

- 2. Criteria for choosing the winning bidder/s:
 - a. In determining the winning bid/s, all the bidders who have passed the technical and financial components will be ranked in ascending order based on the amount indicated in the Financial Bid Form. Bidder who will submit the lowest bid for the 10 lots/units of cargo vans will be declared as the winning bidder for the whole project. However, if the offer of the winning bidder is less than 10 lots/units the second lowest bidder will be declared also as winning bidder for the remaining lots/units. When the total no. of lots/units offered by the first and second lowest bidders is still lower than 10 lots/units the next lower bidder/s will be declared again as winner/s for the remaining lots/units until the 10 lots/units will be all awarded.

This Bid Bulletin shall form part of the Bid Documents.
